BACKYARD CHICKEN APPLICATION FORM

- PROPERTY IS USED PRIMARILY AS A SINGLE-FAMILY DWELLING.
- NO MORE THAN 5 CHICKENS MAY BE KEPT ON ANY PROPERTY.
- CHICKENS THAT CROW AND ROOSTERS SHALL NOT BE PERMITTED.
- OUTDOOR SLAUGHTERING OF CHICKENS IS PROHIBITED.
- NO SALE OF EGGS IS PERMITTED. PERSONAL CONSUMPTION ONLY.
- THE FOLLOWING MATERIALS MAY NOT BE USED TO CONSTRUCT THE ENCLOSED AREAS: TARPS, SCRAP LUMBER, PLYWOOD, WOVEN WIRE, SHEET METAL, PLASTIC OR FIBERGLASS SHEETS, OLD DOORS, FABRIC, RUBBER, PAPER, CARDBOARD, OR OTHER NON-TRADITIONAL BUILDING MATERIALS.
- CHICKENS SHALL NOT BE ALLOWED TO ROAM THE PROPERTY. THE ENCLOSED AREA WHERE THE CHICKENS ARE KEPT SHALL BE:
 - LOCATED WITHIN THE REAR YARD. FOR PROPERTIES WITH NO REAR YARD, THE ZONING ADMINISTRATOR MAY APPROVE THE USE OF A SIDE YARD.
 - NOT WITHIN THE DWELLING OR ANY ATTACHED ACCESSORY BUILDINGS.
 - AT LEAST 10 FEET FROM ANY DWELLING.

- AT LEAST 10 FEET FROM ANY OTHER BUILDING ON THE SAME PROPERTY.
- AT LEAST 10 FEET FROM ANY PROPERTY LINE.
- NO MORE THAN 8 FEET IN HEIGHT
- NO LESS THAN 6 SQUARE FEET IN AREA PER CHICKEN AND NO GREATER THAN 80 SQUARE FEET IN AREA TOTAL.
- SHALL BE SCREENED FROM VIEW OF THE STREET AND NEIGHBORING PROPERTIES.
- CONSTRUCTED AS TO ALLOW SUFFICIENT AREA FOR MOVEMENT AND EXERCISE FOR THE CHICKEN.
- CHICKEN COOPS SHALL AT ALL TIMES BE KEPT CLEAN, ORDERLY AND SANITARY CONDITION.

A RESIDENTIAL LAND USE APPLICATION AND \$50 FEE FOR ACCESSORY BUILDING MUST BE SUBMITTED WITH THIS APPLICATION. BY SIGNING AND SUBMITTING THIS FORM, I ACKNOWLEDGE AND COMMIT TO ADHERING TO ALL REQUIREMENTS STATED IN THE CITY OF GRAYLING CODE OF ORDINANCE BACKYARD CHICKENS SECTION 6-18.
